DETAILED DESCRIPTION OF OFFENSE

NOTIFIED OF PROVISIONS OF TEXAS CRIME VICTIM ACT:  
I WAS DISPATCHED TO THE ABOVE LOCATION WHERE I CONTACTED  
O1. O1 SAID THAT C WAS SUPPOSE TO CHECK OUT BY 1200 HRS.  
O2 SAID AROUND 1500 HRS THEY WENT TO THE ROOM TO CHECK.  
O1 SAID THEY GOT THE DOOR OPEN A LITTLE BUT THE CHAIN  
WAS ON FROM THE INSIDE. O1 SAID THEY USED A MIRROR AND SAW  
C AGAINST THE DOOR. C WAS UNRESPONSIVE. O1 THEN CALLED  
THE POLICE. UPON ARRIVAL WITH EMS WE OPENED THE DOOR AND I USED  
THE MIRROR TO LOOK BEHIND THE DOOR. I COULD SEE C AGAINST THE DOOR. THERE  
WAS STUFF COMING OUT OF C'S NOSE AND I COULD SEE THAT C'S LIPS  
WERE BLUE. I USED A PAIR OF BOLT CUTTERS (PROVIDED BY MAINTENENCE)  
TO CUT THE CHAIN. MYSELF AND EMS MADE ENTRY. THERE  
WAS ALSO A CHAIR AGAINST THE DOOR THAT WE MOVED TO GAIN  
ENTRY. UPON ENTRY WE NOTICED C HAD HUNG HERSELF FROM THE DOOR USING  
A BED SHEET. O4 PRONOUNCED C AT 1543 HRS (EMS CASE 05029648).  
O2 AND O3 WERE NOTIFIED AND MADE THE LOCATION. O5 WAS ALSO CONTACTED  
AND MADE THE LOCATION. OFFICER. G. THOMAS #1430 CONTACTED C'S  
HUSBAND, O6, AT HOME AND NOTIFIED HIM. O7 WAS CONTACTED ALONG  
WITH CONTRACT AMBULANCE AND REMOVED C.
